I hereby make application to participate in the HGCA Antique & Collectors Show to be held in conjunction with the Houston Gun Show. It is agreed that I am contracting for space as an independent contractor with the Houston Gun Collectors, Assn., Inc.

**CONDITIONS OF CONTRACT:** Each booth space will be 16' X 12' with two sides open to the public aisles. If a dealer rents more than one space; they will be adjacent.

**TABLES & CHAIRS:** three 8' tables furnished with each space. Additional 8' X 30" tables may be rented at \$15.00 each. Limited supply, reservations recommended to assure availability. Tables must be draped to floor on aisle sides and have appropriate top cover. Two chairs are furnished per space.

**ELECTRICITY:** Available through Reliant Center Event Services for an additional fee. It is best to order electricity two weeks before set up day for lower rates. Call Harper Wood Electric Co. 713-659-7786.

**SALES TAX NUMBERS REQUIRED:** Dealers will be responsible for collecting all applicable taxes. You must complete the sales tax form provided and return it to the tax box by the end of the show.

**SECURITY:** Furnished on 24-hour basis by H.P.D. officers, however each dealer is responsible for his/her own property.

**INSTALLATION OF EXHIBITS:** Spaces will be available for setup on Friday before the show dates from 3am to 6pm. NO SATURDAY SETUP. The rear-loading door will not be re-opened until Sunday 5pm. Unloading help is limited, be prepared to unload yourself. Enter the North Stadium Dr. entrance.

**BOOTHS MUST BE OPEN DURING PUBLIC SHOW HOURS:** Saturday, 9am-5pm, Sunday 10am-4pm.

**ADMITTANCE TO HALL:** FRIDAY by member or exhibitor badge only. Two badges will be furnished with each booth rental; additional badges purchased for \$10.00 each. Enter through loading door only.

**PARKING PERMIT:** ONE permit is issued per booth space. Additional permits (\$25.) may be purchased from Reliant Center for in/out privileges. You must enter on North Stadium Dr on Friday for free parking. No refunds.

**FEDERAL, STATE & LOCAL LAWS** - must be obeyed. NO ALCOHOLIC drinks or pets permitted - Local Ordinance. No photography permitted.

**MERCHANDISE** - is restricted to Antique and/or Collector's items as defined by show management. The following items will not be permitted: AMMUNITION, CARTRIDGE FIREARMS, CAMERAS, MOUNTED HEADS, used household appliances, garage sale or flea market material; political, racial or ethnic material of demeaning or inflammatory nature. Merchandise must be displayed within dealer's booth space. HGCA reserves the right to remove merchandise it considers objectionable.

**CANCELLATIONS** must be in writing and postmarked no later than first day of the month of the show.

**EXHIBITORS MUST DISMANTLE** booths on Sunday of the show date at 5pm and have them removed by 8pm. Security starts clearing the Reliant Center at this time.
